AN ORDINANCE
ENACTING SECTION 139.093 OF THE
BROOK PARK CODIFIED ORDINANCES, ENTITLED
"PART-TIME CLERKS--SAFETY DEPARTMENT,
AND DECLARING AN EMERGENCY

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Brook Park Codified Ordinances shall be supplemented by enacting a new section, entitled "Part-Time Clerks Safety Department" and is hereby enacted to read as follows;

139.093 PART-TIME CLERKS--SAFETY DEPARTMENT.

- (a) Establishment. There is hereby created the positions of Part-Time Clerks in the Safety Department, effective as of October 1, 2014.
- (b) Duties. Part-Time Clerks in the Safety Department shall perform those duties and responsibilities required to operate the Dispatch/Records Center, and other duties and responsibilities as prescribed by the Chief of Police.
- (c) Compensation. The part-time clerks in the Safety Department shall be hired as part-time employees and shall be compensated as follows: minimum salary-\$18.26 per hour, maximum salary-\$21.15 per hour.

SECTION 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for further reasons to enact Section 139.093 of our Codified Ordinances; therefore, this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor.
