AN ORDINANCE  
AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT  
BETWEEN BREWER-GARRETT COMPANY AND THE CITY OF BROOK PARK,  
AND DECLARING AN EMERGENCY

WHEREAS, a contract between the City of Brook Park and Brewer-Garrett Company was executed on September 1, 2002; and

WHEREAS, said contract provided for Brewer-Garrett Company to perform services for the maintenance of City buildings;

WHEREAS, the contract for these services expired on August 31, 2014, and the City of Brook Park would like to extend this contract for an additional four months.

NOW THEREFORE BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Finance Director is hereby authorized to pay Brewer-Garrett for professional preventive and predictive maintenance services for the City of Brook Park's buildings.

SECTION 2: The money needed for the aforesaid transaction shall be in the amount of \$10,733.00 per month in advance, not exceeding \$42,932.00.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of said City, and for the further reason to extend our professional services agreement with

Brewer-Garrett; therefore, this Ordinance shall remain in force immediately from and after its passage and approval by the Mayor.
