AN ORDINANCE
AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE
TO PREPARE SPECIFICATIONS AND FURTHER AUTHORIZING
THE MAYOR TO ADVERTISE FOR BIDS AND TO
ENTER INTO A CONTRACT WITH THE LOWEST AND/OR BEST BIDDER
FOR THE CONVERSION OF A
1986 FORD L8000 - SEWER VACTOR
TRUCK TO A DUMP TRUCK WITH SNOW PLOW PACKAGE,
AND DECLARING AN EMERGENCY

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Brook Park, State of Ohio, that:

SECTION 1: The Director of Public Service is hereby authorized to prepare specifications for the conversion of a 1986 Ford L8000 - sewer vactor truck to a completed dump truck with snow plow package.

SECTION 2: The Mayor is hereby authorized to advertise for bids and to enter into a contract with the lowest and/or best bidder for the conversion of same.

SECTION 3: The money needed for the aforesaid transaction shall be paid from funds theretofore appropriated for said purpose.

SECTION 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of public peace, health, safety and welfare of said City, and for the

further reason to enter into a contract for the conversion of a sewer vector truck to a dump truck with snow plow; therefore, this Ordinance shall take effect and be in force immediately from and after its passage and approval by the Mayor..
